NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Freestyle Metropolitan District No. 4 shall and hereby does amend the budget for the fiscal year 2023 as follows:



**Electronic Record and Signature Disclosure**

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, CliftonLarsonAllen LLP (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
